New York's Early Intervention Program (EIP) is administered by the New York State Department of Health through the Bureau of Early Intervention. To be eligible for EI services, children must be under 3 years of age and have a confirmed disability or established developmental delay, as defined by the State, in one or more of the following areas of development: physical, cognitive, communication, social-emotional, and/or adaptive. The purpose of this module is to inform families about the steps in the Early Intervention Program.
