Dear Provider,

We are aware that your practice is utilizing the GeneXpert (XpertRHCV) Point of Care (POC) hepatitis C virus (HCV) diagnostic testing instrument. The HCV test results of patients tested using the XpertRHCV are important for public health surveillance purposes and tracking New York State's progress toward hepatitis C elimination by 2030. We strongly encourage you to report these test results (detectable/undetectable), to the New York State Department of Health via the Electronic Clinical Laboratory Reporting System (ECLRS).

Most diagnostic testing is performed by clinical laboratories which automatically report the results to ECLRS. However, because the Xpert®HCV is a point of care test done outside of the laboratory, we are encouraging all physician owned and operated labs under the New York State Department of Health Physician Office Laboratory Evaluation Program (POLEP) to report the results.

Reporting of the Xpert®HCV diagnostic test results can be done in the following ways.

- Utilizing an interface between your electronic health record and ECLRS.
- Entry into the ECLRS.

- Entry into SimpleReport. SimpleReport is a fast, free, and easy way for your organization to report results to public health departments. https://www.simplereport.gov/using-simplereport/

All NYS providers are mandated under the NYS Sanitary Code (10 NYCRR Section 2.10) to report all suspected or confirmed cases of HCV. This includes patients with a positive HCV antibody test and/or a positive HCV RNA test. Reports should be made to the local health department in the county in which the patient resides within 24 hours of diagnosis. Providers may be contacted by local health departments either by phone or in writing for additional information and should ensure that requested information is provided promptly.

Additionally, in May 2024, new HCV screening requirement went into effect in NYS under Public Health Law Section 2171. Providers and settings offering primary care services and all emergency departments must offer an HCV screening test to:

- All persons 18 years of age and older.
- All persons under the age of 18 at risk for HCV.

Finally, all providers attending to a pregnant person must order an HCV screening test during each pregnancy under Public Health Law Section 2500-I. For more information on these HCV screening requirements go to:
