FFY 2024 DWSRF Intended Use Plan Amendment:

DWSRF No. 18622: Village of Alfred, Allegany County. The project cost as listed in the DWSRF IUP is increased to a total project cost of \$1,500,000 due to construction bid prices exceeding original estimates.

DWSRF No. 18575: Village of Greenwich, Washington County. The project cost as listed in the DWSRF IUP is increased to a total project cost of \$11,000,000 due to construction bid prices exceeding original estimates.

DWSRF No. 17987: Town of Oneonta, Otsego County. The project cost as listed in the DWSRF IUP is increased to a total project cost of \$500,000 for a cost increase.

DWSRF No. 17986: Town of Oneonta, Otsego County. The project cost as listed in the DWSRF IUP is increased to a total project cost of \$1,000,000 for a cost increase.

DWSRF No. 19495: Town of Southeast, Putnam County. The project cost as listed in the DWSRF IUP is increased to a total project cost of \$3,000,000 for a project scope and cost increase.

The amendment will not adversely affect any project on the IUP Project Annual List above the subsidized funding line.
