Summary of Services (consistent language)	ALR communities offer an apartment with three restaurant style meals each day, stimulating activities and social events, scheduled transportation, access to Atria's wellness program, weekly housekeeping and laundry service, maintenance of the apartment, 24-hour emergency call system, common areas and grounds, snacks, supervision, case management, all utilities except cable and telephone and, where needed, assistance with some personal care (e.g., bathing and dressing) and medication assistance. EALR services are additional care services that are provided in an ALR community, as outlined in the residency agreement.
