RE: Statewide Health Information Network – New York Participation by Regulated Facilities

Per [10 NYCRR § 300.6](#), Licensed Home Care Services Agencies, Certified Home Health Agencies as defined in Public Health Law Article 36, and hospices as defined in Public Health Law Article 40 must connect to the Statewide Health Information Network for New York. The first step towards meeting this requirement is to become a Statewide Health Information Network for New York participant by signing the new Statewide Common Participation Agreement.
