Dear Medicaid Provider Administrator:

Please be advised that CY 2023 Medicaid Fee-for-Service (FFS) Nursing Supervision and Nursing Assessment rates have been loaded to eMedNY. As stated in the Department's Dear Administrator Letter (DAL), dated January 13, 2025, Nursing Supervision and Nursing Assessment rates were originally held for additional Departmental review.

The rates will take effect in eMedNY in cycle 2492, check release date of 6/11/2025. These 2023 FFS Nursing Supervision and Nursing Assessment rates were developed based on the data submitted in the 2021 cost reports.

## Attachment A – Instructions for Accessing the Post-Review 2023 FFS Medicaid Rate Sheets in the Health Commerce System (HCS)

1. Login to **HCS**: [https://commerce.health.state.ny.us/public/hcs\\_login.html](https://commerce.health.state.ny.us/public/hcs_login.html) ;
2. Under “My Applications”, select **Healthcare Finance Data Gateway** (or go to “My Content” from the top line menu, then All Applications to search for the application under “P” for Personal Care);
3. Click on the **Publications** Tab;
4. Under **Organization Type**, select “**Personal Care**” from the drop down menu;
5. Under **Collection**, select “**Personal Care Rate Reports**” from the drop down menu;
6. Under **Package**, select the “**2023 Post Review Rates**” from the drop-down menu;
7. Under **Organization**, select your agency, then select **Search**.
8. Next select the **Download** checkbox to save the Dear Administrator Letter and rate sheet pdf files as necessary.
