

Attachment P - Acronyms, Terms, and Definitions

Term	Definition
2FA	Two Factor Authentication is a process that provides identification of users by separate categories of credentials.
Business Associate Agreement (BAA)	Under the U.S. Health Insurance Portability and Accountability Act of 1996, a HIPAA business associate agreement (BAA) is a contract between a HIPAA covered entity and a HIPAA business associate (BA). The contract protects personal health information (PHI) in accordance with HIPAA guidelines.
CBO	Community Based Organization.
Chain of Custody (COC)	Refers to the chronological documentation or paper trail, showing the seizure, custody, control, transfer, analysis, and disposition of physical or electronic evidence.
CIN	Client Identification Number.
CMA	Currier McCabe and Associates, Inc., A Department Service Provider.
CPI-U	Consumer Price Index for All Urban Consumers.
CSC	Computer Sciences Corporation, A Department Service Provider.
Data Exchange Application and Agreement (DEAA)	The DEAA serve as the basis for assessing the appropriateness of releasing Medicaid Confidential Data and when approved by NYSDOH, forms an agreement between the applicant and NYSDOH as to the terms and conditions under which the release will be made.
Delivery System Reform Incentive Program (DSRIP)	DSRIP is the main mechanism by which New York State will implement the Medicaid Redesign Team (MRT) Waiver Amendment. DSRIP's purpose is to fundamentally restructure the health care delivery system by reinvesting in the Medicaid program, with the primary goal of reducing avoidable hospital use by 25% over 5 years.
DOH	Department of Health, referred to as NYSDOH as well as the Department.
eMedNY	Medicaid claims processing and payment systems.
Managed Care Organization (MCO)	The term managed care or managed healthcare is used to describe a variety of techniques intended to reduce the cost of providing health benefits and improve the quality of care ("managed care techniques") for organizations that use those techniques or provide them as services to other organizations ("managed care organization" or "MCO").
MAXIMUS	A Department Service Provider.
Medicaid Analytics Platform Portal (MAPP)	Provides tools and program performance management technologies to Performing Provider Systems (PPSs) in their effort to develop and implement transformative projects through the Delivery System Reform Incentive Payment (DSRIP) Program. Supports care management efforts for the State's Health Home (HH) program.

Medicaid Redesign Team (MRT)	A team of stakeholders tasked by Governor Cuomo with developing a multiyear reform plan for New York State's Medicaid system.
National Change of Address (NCOA)	A secure dataset of approximately 160 million permanent change-of-address (COA) records consisting of the names and addresses of individuals, families and businesses who have filed a change-of-address with the USPS.
NIST 800-53	Security and Privacy Controls for Federal Information Systems and Organizations.
Nixie label	The label name given by the United States Postal Service to a piece of mail which is undeliverable as addressed.
NYSDOH	New York State Department of Health.
OASAS	Office of Alcoholism and Substance Abuse Services.
OHIP	Office of Health Insurance Programs.
OMH	Office of Mental Health.
Opt-Out	A process that provides Medicaid members with an opportunity to opt out of data sharing for the New York State Delivery System Reform Incentive Payment (DSRIP) program.
Performing Provider System (PPS)	The entities that are responsible for creating and implementing a DSRIP project are called "Performing Provider Systems", abbreviated "PPS". Performing Provider Systems are providers that form partnerships and collaborate in a DSRIP Project Plan.
Personally Identifiable Information (PII)	Per US privacy law and information security, PII is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context.
Protected Health Information (PHI)	Individually identifiable information (e.g., health status, provision of health care) as defined by the Health Insurance Portability and Accountability Act (HIPAA).
Secured file Transfer Protocol (SFTP)	A secure version of the File Transfer Protocol (FTP).
SWG	Security Workgroup at NYSDOH.
System Security Plan (SSP)	Provides an overview of the security requirements of the system and describes the controls in place or planned for meeting those requirements. For the purpose of this RFP, the SSP is based on NIST 800-53.
