



## Notification to Health Homes, Children's HCBS and CFTSS Providers, 29-I Health Facilities, and Medicaid Managed Care Plans and HIV Special Needs Plans (MMCPs) regarding 1% ATB Rate Increase and 5.4% COLA

**To:** Health Homes Serving Children and Adults, Children and Family Treatment and Support Services (CFTSS) Providers, Children's Home and Community Based Services (HCBS) Providers, 29-I Health Facilities, and Medicaid Managed Care Plans (MMCPs), including Mainstream Medicaid Managed Care and HIV Special Needs Plans

**DATE:** October 3, 2022

In accordance with the 2022-23 Enacted Budget, the 1% Across the Board (ATB) Medicaid Rate Increases effective for dates of service on or after April 1, 2022, have been loaded in eMedNY for Health Homes Serving Children and Adults. The chart posted on the DOH website at

**Please Note:** Care Coordination Organization Health Homes (CCO-HH) and Adult Health Home Plus (Adult HH+) are eligible for a 5.4% Cost of Living Adjustment (COLA) and are therefore excluded from the 1% ATB. Additionally, final approval is being sought for the 1% Across the Board (ATB) Medicaid Rate Increases effective for dates of service on or after April 1, 2022, for the 29-I Health Facilities for the Core Limited Health Related (Per Diem) **and** Other Limited Health Related Services and the website will be updated.

DOH is seeking final approval of the 5.4% COLA Medicaid Rate adjustment effective for dates of service on or after April 1, 2022, including for Child and Family Treatment and Support Services (CFTSS), Children's Home and Community-Based Services (HCBS) and CCO-HH and Adult HH+.
