RE: Clarification #8 for Measurement Year (MY) 2024 Updates

Dear Colleague,

This letter contains information about the 2024 Quality Assurance Reporting Requirements (QARR) Technical Specifications: NYS MY2024 QARR List of Required Measures (Table1) and the Exchange MY2024 PLD File Specifications (PDF). The files are posted on our Managed Care [Information for Health Plans](#) page. The revised specifications should be used in the plans' processing for MY2024 QARR.
