

Since there is only one Inpatient Psychiatric Hospitalization Service in Broome County and none within Chenango and Tioga Counties, UHC is contracted with providers in neighboring counties to meet network requirements. UHC is contracted with Cortland Regional Medical Center (Cortland County) and United Health Services Hospital (Broome County). In addition, UHC is contracted with Arnot Ogden Medical Center (Chemung County) and University Hospital (Onondaga County). UHC identified that the logic did not capture SIUH for PNDS reporting for these services. UHC is working on correcting the logic and will include PH for SIUH in the next PNDS submission.</li> </ul> <p>The SIUH record will be updated to reflect PH level of care in time for the next PNDS submission that is due July 1<sup>st</sup>. UHC validated that 410 Winthrop Street is the correct address. </li> </ul> <p>The H&amp;H contract will be amended to include 410 Winthrop Street for CPEP. Once completed, the system will be updated to reflect the correct address to be reflected in the next PNDS submission.</p> <p><b>Monitoring and Auditing Component:</b> On a quarterly basis, the PNDS report provides network deficiencies. Following DOH review, one provider was confirmed for PH services in Richmond County. Based on the contract review, UHC failed to accurately report this provider in the PNDS.</p> <p>UHC also failed to accurately report the providers in Kings County for CPEP services. UHC consistently reported only one contracted CPEP provider for four consecutive quarters, from July 2022 (Q3) through June 2023 (Q2), failing to meet the required network standards of two providers contracted per county for CPEP services as outlined in the Medicaid Model Contract.</p> <p>UHC confirmed contracts with 2 providers in an email on January 9, 2024, and submitted the provider contracts in an email on January 29, 2024. Following DOH review, both providers were confirmed for CPEP providers in Kings County. **35.1 Contractor and SDOH Compliance With Applicable Laws**

Notwithstanding any inconsistent provisions in this Agreement, the Contractor and SDOH shall comply with all applicable requirements of the State Public Health Law; the State Social Services Law; the State Finance Law; the State Mental Hygiene Law; the State Insurance Law; Title XIX of the Social Security Act; Title VI of the Civil Rights Act of 1964 and 45 CFR Part 80, as amended; Title IX of the Education Amendments of 1972; Section 504 of the Rehabilitation Act of 1973 and 45 CFR Part 84, as amended; the Age Discrimination Act of 1975 and 45 CFR Part 91, as amended; the ADA; Title XIII of the Federal Public Health Services Act, 42 U.S.C § 300e et seq., regulations promulgated thereunder; the Health Insurance Portability and Accountability Act of 1996 (P.L. 104-191) and related regulations; the Federal False Claims Act, 31 U.S.C. § 3729 et seq.; Mental Health Parity and Addiction Equity Act of 2008, (P.L. 110- 345); for Contractors operating in New York City, the New York City Health Code; and all other applicable legal and regulatory requirements in effect at the time that this Agreement is signed and as adopted or amended during the term of this Agreement. The parties agree that this Agreement shall be interpreted according to the laws of the State of New York.

**21.19(a)(ii)(b)(i)(C)(II)(D)(I)(E)(II)(F)(I) Behavioral Health Service Providers** a) The Contractor will include a full array of mental health and Substance Use Disorder Service providers in its networks, in sufficient numbers to assure accessibility to Benefit Package services for both children and adults, using either individual, appropriately licensed practitioners or New York State Office of Mental Health (OMH) and Office of Alcoholism and Substance Abuse Services (OASAS) licensed programs and clinics, or both...ii) In addition to the requirements set forth in 21.19(b), upon the date of the Behavioral Health Benefit Inclusion in a geographic service area, the Contractor must establish contracts with any providers operated, licensed or certified by OMH or OASAS with five or more active Plan members in treatment, as determined by OMH and OASAS. ## **Findings:**

Based on Medicaid Managed Care Plan (MMCP) data reported to the Provider Network Data System (PNDS) collected by the New York State (NYS) Department of Health (DOH), UnitedHealthcare of New York, Inc. (UHC) failed to meet the required minimum behavioral health (BH) network standards, as outlined in the Medicaid Model Contract, for the following services:

- Inpatient Psychiatric Hospitalization Services
- Assertive Community Treatment (ACT)
- Partial Hospitalization (PH)
- Comprehensive Psychiatric Emergency Program (CPEP)

In partnership with the NYS DOH, the Office of Mental Health (OMH) reviewed PNDS reports for four consecutive quarters from July 2022 (Q3) through June 2023 (Q2) and contacted UHC confirming the following issues for meeting network standards for these services:

1. UHC does not contract with the minimum number of providers required for the following services:
  - Inpatient Psychiatric Hospitalization Services
  - Assertive Community Treatment (ACT)
  - Partial Hospitalization (PH)
2. UHC did not accurately report BH providers in their network for the following services:
  - Partial Hospitalization (PH)
  - Comprehensive Psychiatric Emergency Program (CPEP)

### **Issue 1:**

Specifically, UHC failed to meet the network requirements of two providers in Broome, Chenango, and Tioga County for Inpatient Psychiatric Hospitalization Services. UHC consistently reported only one contracted Inpatient Psychiatric Hospitalization Services provider for four consecutive quarters, from July 2022 (Q3) through June 2023 (Q2), failing to meet the required network standards of two providers contracted per region for Inpatient Mental Health as outlined in the Medicaid Model Contract.

UHC also failed to meet the network requirements in Fulton County and Herkimer County for ACT. UHC consistently reported zero contracted ACT providers for four consecutive quarters, from July 2022 (Q3) through June 2023 (Q2), failing to meet the required network standards of two providers contracted per region for ACT as outlined in the Medicaid Model Contract.

UHC confirmed these deficiencies in an email to DOH on January 9, 2024.

In addition, UHC also failed to meet network requirements for PH services in Richmond County. UHC consistently reported zero contracted PH providers for four consecutive quarters, from July 2022 (Q3) through June 2023 (Q2), failing to meet the required network standards of two providers contracted per county for PH services as outlined in the Medicaid Model Contract.

UHC confirmed contracts with 2 providers in an email on January 9, 2024, but only submitted one provider contract in an email on January 29, 2024. Following DOH review, UHC does not meet the minimum required of 2 PH providers in Richmond County.

For Tioga and Chenango counties as there are no available providers for contracting. Broome only has the above facility United Health Services which is already contracted with UHC and reported through PNDS submission.

### **9/26 UHC Response:**

UHC is meeting the State's network requirements/standards. Since there is only one Inpatient Psychiatric Hospitalization Service in Broome County and none within Chenango and Tioga Counties, UHC is contracted with providers in neighboring counties to meet network requirements. UHC is contracted with Cortland Regional Medical Center (Cortland County) and United Health Services Hospital (Broome County). In addition, UHC is contracted with Arnot Ogden Medical Center (Chemung County) and University Hospital (Onondaga County). Robert Packer Hospital (Bradford County, PA, close to Broome) is an alternative option if needed.

## **ACT:**

### **Fulton**

- Assertive Community Treatment (ACT) : There are no available providers in Fulton county as per OMH website: OMH Find a Mental Health Program Website [Find a Mental Health Program \(ny.gov\)](https://www.omh.ny.gov/omhweb/find_a_mental_health_program.htm).

### **Herkimer**

- Assertive Community Treatment (ACT): There are no available providers in Herkimer county as per OMH website: OMH Find a Mental Health Program Website [Find a Mental Health Program \(ny.gov\)](https://www.omh.ny.gov/omhweb/find_a_mental_health_program.htm).

Per OMH, there are no available ACT providers to contract with in Fulton and Herkimer county.

## **9/26 UHC Response:**

UHC is meeting the State's network requirements/standards. There are no available state-designated ACT providers in Fulton and Herkimer counties for UHC to contract. Members within these counties who are referred for ACT services through a Single Point of Access (SPOA) process, which is managed by the Local Department of Social Services, will be assigned to one of the ACT programs in a neighboring county. UHC is contracted with 100% of state-designated ACT programs in Western and Central NY.

## **Partial Hospitalization Services:**

- **Staten Island University Hospital (SIUH)** is contracted to provide PH services. UHC identified that the logic did not capture SIUH for PNDS reporting for these services. UHC is working on correcting the logic and will include PH for SIUH in the next PNDS submission.

The SIUH record will be updated to reflect PH level of care in time for the next PNDS submission that is due July 1<sup>st</sup>. Testing and auditing will occur during the system reporting update.

- **Richmond University Medical Hospital (RUMC)** UHC's contracting team outreached to the facility to add PH services to their contract. In the interim, UHC has been establishing Single Case Agreements as needed.

UHC will work with RUMC to amend their contract to add PH services.

## **Issue 2:**

Specifically, UHC failed to accurately report providers for PH services in Richmond County. UHC consistently reported zero contracted PH providers for four consecutive quarters, from July 2022 (Q3) through June 2023 (Q2), failing to meet the required network standards of two providers contracted per county for PH services as outlined in the Medicaid Model Contract.

UHC confirmed they contract with 2 providers in an email on January 9, 2024, but only

submitted one provider contract in an email on January 29, 2024. Following DOH review, one provider was confirmed for PH services in Richmond County. Based on the contract review, UHC failed to accurately report this provider in the PNDS.

UHC also failed to accurately report the providers in Kings County for CPEP services. UHC consistently reported only one contracted CPEP provider for four consecutive quarters, from July 2022 (Q3) through June 2023 (Q2), failing to meet the required network standards of two providers contracted per county for CPEP services as outlined in the Medicaid Model Contract.

UHC confirmed contracts with 2 providers in an email on January 9, 2024, and submitted the provider contracts in an email on January 29, 2024. Following DOH review, both providers were confirmed for CPEP providers in Kings County. Based on the contract review, UHC meets the BH network standards but failed to accurately report providers in the PNDS.

### **UHC's Response:**

#### **CPEP Services**

- **Brookdale Hospital**  
Brookdale is contracted with UHC for CPEP services and has been reported in the PNDS submission since Q3 2022.
- **Kings County Hospital** - UHC has been submitting Kings County CPEP facilities in the quarterly PNDS reporting. H&H is not being accepted due to a mismatched address and OMH ID. Per their contract, CPEP services are listed at 451 Clarkson Avenue, which was submitted to DOH for review on January 29, 2024. UHC validated that 410 Winthrop Street is the correct address.

**Action Steps** - The H&H contract will be amended to include 410 Winthrop Street for CPEP. Once completed, the system will be updated to reflect the correct address to be reflected in the next PNDS submission.

**Monitoring and Auditing Component:** On a quarterly basis, the Network Management Team reviews the PNDS report for deficiencies which includes the following:

- Recruit providers based on the State's list of available providers.
- We also monitor State websites for newly designated providers and programs.

The auditing component includes determining why existing providers were not correctly reported in the PNDS report. This includes reviewing the provider record set-up and the OMH and OASAS reference files

9/26 UHC Response:

UHC also has an internal process to identify and track recruitment status for newly designated OMH providers. UHC conducts reviews weekly. On 9/26/24, UHC reviewed and validated that UHC is in contract with 100% of state-designated ACT programs in Western and Central NY.
