All MAPP HHTS Issues MUST be submitted to MAPP CCC

- Some providers have been emailing DOH staff directly with MAPP HHTS questions
 - ➤ How do I access MAPP HHTS?
 - Where can I find training materials?
 - > I need a relationship set up in the system.
 - ➤ How do I find ... in the system?
- > <u>ALL</u> questions about MAPP HHTS <u>MUST</u> be sent to MAPP Customer Care Center (CCC).
- ➤ MAPP CCC documents all questions (call and emails) they receive and then sends questions to subject matter experts. Questions are then answered in the order they are received.
- ➤ Going forward, MAPP CCC questions will be responded to prior to any questions that should have been submitted to MAPP CCC but were instead sent directly to DOH staff.


