Best Practices for Completing the MU Workbook

Nothing makes the NY Medicaid EHR Incentive Program Support Team happier than seeing a provider be approved for payment. With this in mind, we want to offer some tips and best practices for completing the MU Workbook.

- Before you begin, be sure to click the **Enable Content** button.
- Completing the **Federal Information** tab is a very important step. Be sure to fill it out completely and with accurate information, selecting the appropriate **Participation Year** and **Payment Year**. These selections will drive the fields that populate on the Meaningful Use tab.
- Are you a returning provider who previously completed a MU Workbook for 2015? Be sure to start a new workbook for 2016, rather than changing the data in your 2015 workbook.
