The Meaningful Use Registration for Public Health (MURPH) System is excited to announce the new Audit Report Card. This is an additional application feature that provides new functionality to the MURPH system. The Audit Report Card is a self-service utility that provides direct access to Meaningful Use (MU) Public Health On-boarding Statuses for Eligible Professionals (EPs), Eligible Hospitals (EHs) and their representatives. This new feature allows eligible providers and their representatives quick and easy access to a report of their public health status history for all of the Public Health registries with which they have registered intent to submit data.
