## Public Health Reporting LISTSERV: 11/30/2017

EHR Incentive Program Public Health  
Reporting Objective



### Last Day to Register - Friday December 1, 2017

All providers must register their intent to submit data to public health before or within 60 days of the start of their EHR Reporting Period.

The last 90-day EHR Reporting Period available in 2017 is from October 3, 2017 - December 31, 2017. The final day a registration of intent may be submitted for that period is **Friday, December 1, 2017**. Registration of Intent is submitted via the Meaningful Use Registration for Public Health (MURPH) System, which is hosted on the NYS Health Commerce System (HCS).

***Note: Only one registration is required. If you have previously registered, you may "edit" the existing registration with any changes. A new registration should NOT be submitted.***

- Exclusion from a public health reporting measure does not count as meeting the measure ([FAQ#1.3](#))
- Providers may attest to Modified Stage 2 or Optional Stage 3 in 2017. Requirements: [2017 Modified Stage 2](#) & [2017 Optional Stage 3](#)
