MURPH Registration Deadline for 2018 MU Attestations

Eligible Providers must register their intent to submit data to the appropriate Public Health registries before or within 60 days from the start of their EHR Reporting Period!

For those attesting to 2018 Meaningful Use, the last day to register is December 1st.

Eligible Professionals who previously registered with MURPH, and need to make any changes, must update their existing MURPH Registration rather than start a new registration.
