Technical Updates

Pilot Testing

- NYSDOH has begun testing the Electronic Visit Verification API with a select number of testers
- We are still asking Providers (who plan on submitting EVV data themselves) and Manager Care Organizations to reach out if they are interested in testing

- Additional EVV data submitters will be asked to test in early fall
