For All Trauma Hospitals

- 1. What level is your trauma center?
- 2. What region is your center located in/which RTAC is your center a member of?
- 3. Are you concerned about receiving a Type II deficiency related to Standard 4.24 Replant Services at your next VRC visit?
- 4. Do you offer replant services at your institution?
- 5. If so, are your replant services available continuously e.g., 24/7/365 without gaps in coverage?

For Non-Replant Hospitals

- 1. Do you have a written transfer agreement with a replant center, and if so, with what institution?
- 2. If you have a written transfer agreement, is the receiving institution a trauma center?
- 3. If you don't have a written transfer agreement, where do you transfer patients for replant evaluation?



SITES WITHOUT REPLANT CAPABILITIES

- 7/20 concerned about criteria deficiency
- 7/20 have no written transfer agreement
 - Only 3 of these were concerned about criteria deficiency
- Average Transport Time: 71 minutes by ground
 - Range 15-300 minutes
